**A RESOLUTION APPROVING THE CANVASS OF THE  
2023 HARRISVILLE CITY**

**MUNICIPAL GENERAL ELECTION**

**WHEREAS**, on November 21, 2023, the regular Municipal General Election was held;  
and

**WHEREAS**, on December 6, 2023, the City Council convened as the Board of  
Canvassers, to canvass the returns of the said Municipal General Election; and

**WHEREAS**, the City Council, during the canvass of the ballots, inspected the ballot  
results by precinct including any absentee ballots received by Election Day; and

**WHEREAS**, the City Council has determined that the election and voting were  
conducted in compliance with the law,

**NOW, THEREFORE**, be it resolved by the City Council of Harrisville City, Utah, as  
follows:

**Section 1:** The City Council, as the official Board of Canvassers, hereby accepts and  
approves the reports entitled “Election Summary Report” and “Statement of Votes Cast” for the  
2023 Harrisville City Municipal General Election held on November 21, 2023.
