Any player, spectator or parent who does not adhere to these policies will be asked to leave the building and in the case of a parent, will result in their child being removed from the game. If circumstances are of a serious nature (profanity, abusive language, threatening of an official, etc.) a forfeit can be called on the violating team.

Special rules may be put into place per the Health Department/Weber School District. All participants and spectators will abide by said rules or they will not be allowed to participate or attend games.
